Bob made a motion to accept the minutes; Tom seconded the motion.

**Public Comment**

Dave Broadt stated that the Fire Company will be having their annual Easter egg hunt on April 14<sup>th</sup> at the township field. Tom stated that they are aware, and a police officer will be on duty to assist with traffic.

Mr. Bodman asked if there is a list of properties in the Agricultural Area, Tom stated yes, and Mr. Bodman requested a copy.

Mr. Bodman stated that at the last two meetings, Larry noted that he could not get a hold of Josh Klingerman to confirm the will be on the Zoning Hearing Board and wanted to know if he was able to confirm. Larry Frace stated he did, and Josh Klingerman will be on the board.

Mr. Bodman asked if the bed & breakfast at the Richard and Debra Shuman property, The Barn at Hidden Acres was in compliance with the UCC codes. Larry Frace stated that they lost the UCC Appeal and they may not use the building as a bed & breakfast until they are issued a UCC Permit. They may use the building as a residential building.

Mr. Bodman asked if Larry had a chance to prepare a draft property maintenance code. Larry stated that he has a list of what sections Brior Creek Township had removed and will provide a copy to the supervisors for their review. Larry also stated that he will have five copies made of the full ICC Code for the supervisors to review.

Mr. Bodman stated that he is still concerned that the township does not go thru what Salem Township is going thru with their Ag Security Act and that when the township's Ag Security Area Ordinance was not registered with the State. Tom stated that the ordinances of each property are filed at the courthouse. Tom noted that the last review of the properties was August of 2014 and the last properties added were Randy & Ronnie Rhoads in 2009. Mr. Bodman's property needs to be changed on the listing since it still lists Gerald & Mary Ellen Bodman and should be Gerald & Shirley Bodman. Tom stated is working on getting everything straightened out. It was also clarified to be eligible for the Ag Security Area the farm property must have 10 acres or more, or at least has over \$2,000 of income from farming.

### **New Business**

Steve Shannon Ag Security Request

Tom read correspondence received from Steve Shannon requesting that he wants to stay in the Ag Security area for the Diehl farm in Main Township which is now the Shannon Farm or Shannon Investments.
