Public Comment

Candice Cotterman stated that she is aware there has been discussions on a burn ordinance for the township. She stated that her neighbor has had a trash bag sitting near the road outside for over three weeks now.

Pam stated that an ordinance has been discussed but the supervisors have not done anything with it.

Adam stated that the township does have an ordinance for regulating junk, garbage, rubbish and abandoned/junk vehicles which he can address and he will stop by the residence and send a letter if needed.

Dave Broadt stated that he cautions the supervisors define who and how it is enforced if they decide on writing up an ordinance for burning.

Jerry asked what the Special Account movement to the General Fund of \$9,849 was for since he did not see the deposit in the General Fund. Lisa stated that it was the payment to Ackley's for the furnace, and the transaction was last month and the balance of \$123,910.39 is the current balance. She will correct on the minutes.

Joyce Linguosky stated that she is working with the residents of Wonderview to get a price for the 240 ft of guiderail for the entrance so they know what the costs will be.

Mr. Turowski stated that it is entirely on the residents of Wonderview and Catawissa Township. Main Township cannot give any direction on what they do since it is not in Main Township.

Mr. Mitchell stated that he had an encounter with Derr's dogs being on the loose and being nasty and

almost nipped him when he was walking. Candice Cotterman stated their dogs are always loose and it is a problem.

Phil Savidge stated that he would have to report to the dog warden for Columbia County. He asked if Mr. Mitchell could provide the exact dates and time to put a time stamp on it. He stated that he is aware it is an on-going issue, and they need to keep reporting to the dog warden. Phil stated he will talk with Mr. Mitchell after the meeting.
