Steve Kehoe from the state worked up the estimate and felt that if it was bid out as one project, the township’s would receive a better price, so the bid was put out as one project and Roaring Creek will pay for this portion and half the cost of advertising. From the estimate from the state, Main Township’s portion would be about 57% from the bridge to the township line and Roaring Creek’s would be @ 43%, from their township line to the end.

Randy also stated that there were only two bids received since they are the only two companies that sell the oil so there are no local contractors that do it anymore.

Mr. Turowski reviewed the bid documents submitted and all is in order.

Bob made a motion to accept the bid from Midland Asphalt, Inc, who submitted the lower bid; Pam seconded the motion; all were in favor.

Old Business

New Building

Pam stated that we are still in the permit stage with the Columbia County Planning Commission, and there has been no movement or progress yet.

Dirt & Gravel Project

Randy stated that he met with Steve Kehoe from PennDot on the West Maple grant project, and he will be drawing up the bid documents so it can be advertised and opened at the April meeting. The project will be to add fill, DSA and install three pipes and repair one. Randy stated we are very fortunate to get the project awarded and we still have an application for Fire Tower Road, which is a much bigger project so will be more difficult to get approved.

Fisher Run Road

Randy stated that Robert Young did some prep work with gravel and used their power roller to prepare for the tar and chip project.

New Business

Truck Repairs

The old yellow truck that just had a new box put on it is having some motor issues. They received one estimate for the repairs and will get another. The vehicle has under 40,000 miles so it is worth fixing.

Mountain Road

Randy stated that they received one estimate from Robert Young Inc, for doing some repair work to Mountain Road, but he cannot justify spending the money on it since there is no winter maintenance. He stated that our guys will fix and fill in the potholes in the spring.
