#### **First Order of Business**

#### **Minutes of Meeting**

Randy stated the October minutes were posted to the webpage for review. Pam made a motion to approve the October minutes; Bob seconded the motion; all were in favor.

#### **Public Comment**

Mr. Bodman asked if there was any progress made yet on the zoning changes to commercial type solar panels. Randy stated that nothing has been done yet.

Bob Edwards stated that the cracks are getting wider on Lookout Drive, and the edges are starting to spider and asked if the guys could check it out. Randy stated that we will work with the state on it.

Allison Haupt, Lookout Drive, stated that it is hard to see coming out at the intersection on Lookout and Mainville Drive and asked if a mirror could be installed. The supervisors explained no mirror could be installed since PennDot will not allow one and it is also a liability issue. She also asked if the hedgerow can be trimmed back on Mainville Drive going down the hill towards the intersection. Bob stated that it will be looked into.

needs to send a letter to the county stating buffer yard is not needed and hopefully they will issue the land use permit by the end of November.

Randy stated that the township will need to get another engineer to assist with the bidding process.

Jerry Bodman asked about the challenge coins. Phil stated they are \$15 per coin and there are still a few left.

Randy stated that an individual is trying to purchase it and he has been mowing and cleaning the property. Bob Edwards asked if the portable toilet will be staying; Randy stated yes.
