

ADDENDUM

Main Township Notice to Bid

Notice is hereby given that the Main Township Board of Supervisors is soliciting bids for a new 40' x 56' x 16' Storage Building which is generally comprised of constructing a building and all incidental work related thereto on the municipal grounds located at 345 Church Road, Bloomsburg, PA 17815 with the following:

Specifications:

Bid Specifications may be emailed as a pdf or picked up in person at the Township Building (by appointment only)

The township will consider separate bids for the following scopes of work or may be all in one:

- Excavation
- Pre-Cast Walls
- Flat concrete work with footers
- Building Construction

The following areas are to be bid as alternates and must be separated from the above bids:

- Electrical
- Overhead Doors

Contractors must be a PA Licensed Contractor. The contractor shall be required to furnish the Township with proof of insurance evidencing liability coverage of One Million Dollars (\$1,000,000) and Workers' Compensation coverage and shall be required to enter into a written contract with the Township.

An optional informative Pre-Bid Meeting will be held at the municipal grounds on **April 22, 2024 at 5:30pm**

Bidders' attention is called to the fact that not less than the minimum wages and salaries in accordance with the provisions of the Pennsylvania Prevailing Wage Act and contained in the CONTRACT DOCUMENTS, must be paid throughout the duration of this project. Bid security, in an amount equal to ten (10%) of the total bid, shall be submitted with each Bid, in accordance with the instructions to Bidders.

The successful Bidder will be required to furnish and pay for a satisfactory Performance Bond and Labor and Material Payment Bond.

Each bid must contain the full name and address of the bidder and be manually signed. The person signing on behalf of the bidder must be authorized to bind the bid in contract. The written bid must be placed in a sealed envelope and labeled "Storage Building" and delivered to the Main Township Office, 345 Church Road, Bloomsburg, PA 17815 prior to **5:30 pm on May 6, 2024**. The bids will be opened and tabulated during the monthly meeting of the Board of Supervisors on **May 6, 2024 at 7:00pm**.

The Board of Supervisors reserves the right to reject any and all bids or portions thereof, and to waive any informality in the bidding.

The selection of the successful bidder shall be made in the best interest of Main Township, as solely determined by the Main Township Board of Supervisors, and bidders acknowledge this by submitting a bid.

Bids may be held for a period not to exceed thirty (30) days from the date of the opening of bids for the purpose of reviewing the bids, before awarding the Contract. In this period of time no Bidder may withdraw their bid.
