Pam made a motion to approve the September treasurer's report as read; Bob seconded the motion; all were in favor.

Public Comment

Brian Long stated that after last month's discussion about the fire tax, he suggested that the tax be changed to a per person amount rather than taxed by property, since he feels that the fire company would make more money. Mr. Turowski stated that fire tax is assessed by millage on all real estate property in the township as required by the Second Class Township Code.

Diane Littlewood from Wonderview wanted to share her frustration of getting nowhere with her concern for guiderails at the entrance to Wonderview. She stated that she has approached everyone she possibly could from Catawissa Township Supervisors, representatives, the county, state and hits a dead end with everyone since it all falls back to Catawissa who states they do not have the money to do anything. Diane also stated that Catawissa will no longer return her calls and even have hung up on her.

Pam stated that the supervisors will try to talk to Catawissa Township supervisor's again.

Tom Phillips from Wonderview stated that he does not feel guiderails should be put in since there would be no where to put the snow when they plow.

Diane Littlewood also stated that she is concerned with the speeding in Wonderview. Phil stated the police have been patrolling more in Wonderview and he goes at different times of the day as well.

Mr. Bodman asked what the payments to Selective Insurance and Heny Dunn Group were for. Lisa stated that they are for insurance premiums. Henry Dunn is the township's new agent and there are policies for the township and fire company for workers' compensation and liability policies and the payments are for the different policies and some go thru the agent and others go directly to the carrier.

Old Business

New Building and Furnace

Pam stated they are still on the contractor's schedule to install a new furnace and AC units in some rooms of the township building.

Ted Oman is still working on the estimate for the land development plan and building which will have to be submitted to the county. Pam stated she will follow-up with Mr. Oman.

Bob stated that the Cobra cameras that were ordered from Bradco were installed on the trucks , making it much easier for the guys driving the trucks to see behind.

New Business

Resolution to Engage a CPA for Auditing
